Dear Mr. Hernandez:

On January 7, 2010, you filed a Texas Public Information Act (TPIA) request with our office. Specifically, you requested "copies of all correspondence about Bowie High School between the office of State Sen. Eliot Shapleigh and the El Paso Independent School District during the past two years."

As you may know, our office organized *Equipo Bowie* along with many community stakeholders to analyze, identify best practices, and then reform systemic challenges in the Bowie feeder pattern. Our concern was that Bowie High School, which in 2008 was in phase four of the *No Child Left Behind* federal act, might be closed. For us and all of El Paso, closing Bowie is not an option.

Recently, several Bowie teachers, administrators, and alumni shared with us some very disturbing news. When 55 percent of an entering freshmen cohort—a jump of more than twice any of the previous five freshmen cohorts—are not enrolled as sophomores at Bowie the following year, it raises very serious concerns. For all of us who care about Bowie, the bottom line is what's best for the students. Toward that end, the *Equipo Bowie* team committed again to push hard in 2010 for the systemic reforms at the entire feeder pattern that will improve dramatically the quality of education for all Bowie students.

Regarding your TPIA request, we are pleased to deliver public information on what is the most important state issue, the education of our children, and thus waive any fees associated with the diligent work that our staff performed over the weekend.
